A refundable tax credit equal to 24% of eligible wages, up to an annual limit of \$83,333 per employee.

To be eligible, your business must:

Have six or more eligible employees.

Focus on services related to:

- Information system design;
- Software publishing.

Carry out the following activities:

- IT consulting services related to technology, systems development and e-business processes and solutions;
- Business process reengineering

- Technology architecture design

- Development, integration, maintenance and evolution of information systems and technological infrastructure;

- Distribution packages

- Software and computer programs

- Technology architecture upgrading

- Integration of hardware and software components

- Design and development of e-business solutions allowing monetary transactions;

Development of security and identification services;

- Electronic imaging

## **Production of Multimedia Titles**

Québec is well known for its creativity and innovative flair in the multimedia sector. To give Québec multimedia companies an extra boost and help them carve out a place among the top industry players, a tax credit is offered for the production of multimedia titles.

What can your company receive?

A refundable tax credit covering up to 30% of your eligible labour expenditure.

To be eligible, your business must:

Produce eligible multimedia titles in Québec:

- titles produced on an electronic medium and run using software that supports interactivity;

- related titles, such as digital animation films associated with an eligible multimedia title produced by your company.

Perform eligible production work:

- all operations necessary to produce the multimedia title, commencing with the design stage and indefinitely

thereafter.
